14th European Youth Parliament for Water

I. Introduction

Based on the Universal Declaration of Human Rights, article n°3 "The Right to Life, Liberty, Personal Security", all humans should have access to potable water.

We, the parliamentarians of the 14th European Youth Parliament for Water (EYPW), which took place in Rovereto, Italy, from the 2nd to the 8th of October, 2017 discussed the topic of "Water and Peace".

We represent the voice of the 14 European countries and participating countries – Armenia, Belgium, Bulgaria, Czech Republic, France, Greece, Italy, Kosovo, Latvia, Malta, Morocco, Russia, Spain, and Turkey.

Our participation in the decision-making process is crucial on grounds of manifestation of our inaction and complacency into serious consequences.

II. Problems Inhibiting "Water and Peace"

- Lack of awareness and education about the issue of water shortage and mismanagement.
- Climate change and its consequences, such as the depreciation of precipitation and the melting of glaciers,
- Lack of transboundary cooperation in water, climate change and peace.
- The depreciating quality of the waterbodies is currently a major concern for the survival of life.
- Population growth puts further pressure on water accessibility and availability.

III. The Proposed Implementations

- Integrate water consciousness in educational programs.
- Encourage transboundary collaboration on "Water and Peace" on a local, regional and international level.
- It is necessary for authorities to incentivise financial institutions (like the World Bank) to give preferential treatment to initiatives related to circular economy.
- Share data, knowledge and expertise of water related issues by means of mass media in order to improve regional water equality.
